This is in contravention of Policies HQD1 and HQD2 of the ACNP. Bucks Decision: Approved: A dormer window to the rear roof slope could be constructed under permitted development as evidenced by the issuing of a lawful development certificate for a dormer of an identical scale under app ref: 23/01809/CPL, while the proposed single storey side/ rear extension would be identical to extant permission 23/01812/APP.
