The retail unit at this point in time does not have a licence for hot food or drinks and will be advertised for 2 years. Cllr Wyatt has asked that they put signs up for no dogs in the LEAP

A tree alongside Brook Farm needs trimming and is obscuring light – Cllr Wyatt requested this is done

<u>Charles Church Site Brook Street</u>- there is no longer anyone on site so Cllr Wyatt will try and contact their office to discuss the landscaping.

Cala site on Weston Road – Cllr Ronson reported that they are planting out the site and all is looking good
