18.078 Apologies:

No apologies were received.

18.079 Declarations of Interest:

There were no declarations.

18.080 Public Participation.

A member of the public asked for clarification on the following items:

- Whether there was a good response to the proposed Community Centre consultation and the Council reported yes, there had been over 340 so far and all had been positive.
- What if the total New Homes Bonus grant applied for was not awarded Cllr Tubb responded that although £500k had been ring fenced from the last round, the further £250k was not guaranteed. However, there may be cost savings through the tender process and an element of shortfall could possibly be made up from Parish Council reserves.
- When would the build be completed Cllr Tubb responded that the build time would be approximately 12 months and the earliest completion was expected to be summer 2020.
- What sustainability measure are being considered for the new building and have you thought
 about grants for this? Cllr Mason reiterated that there were grants available and Cllr Tubb
 explained that all options would be fully explored once the Council had secured the funding
 for the project in general.

18.081 Application to New Homes Bonus (NHB):

The NHB Business Plan had been circulated prior to the meeting along with a copy of the outline budget for the project (see below), including funding sources and amounts. Cllr Tubb pointed out there was an estimated £30K surplus, when all funding and estimated costs had been taken into account. Cllr Wyatt pointed out that there was an erroneous £ sign within the budget description and it was AGREED that this would be corrected.
